4.1. Description of first aid measures

The filament is not hazardous to human health. The information on first aid provided below relates to the situation when the exposure was caused by working with the hot product during printing.

Eye contact: During printing process: splashes of liquid filament may cause burns. Put on

sterile dressing. Contact an ophthalmologist immediately.

Skin contact: <u>During printing process:</u> possible thermal burns. Rinse damaged skin with

cold water. Put on sterile dressing. Contact doctor.

Inhalation: <u>During printing process:</u> remove the victim to fresh air. Keep warm and calm.

Consult a doctor, if disturbing symptoms occur.

Ingestion: Exposure by this route does not typically occur. If swallowed, rinse mouth with

water. Do not induce vomiting. Contact a doctor, show container or label.

4.2. Most important symptoms and effects, both acute and delayed

• Skin contact: contact with the product at high temperature may cause severe burns.

- Eye contact: at high temperatures, the vapors generated during printing process may cause irritation.
- <u>Inhalation</u>: prolonged inhalation of fumes evolved during the printing process may cause headaches, poor concentration, exhaustion.

4.3. Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured. Symptomatic treatment.
